Review / discuss educator input, Review / discussion of possible building projects. Josh Gordon presented results from the community and staff surveys. Reviewed the comments after the tour. People were surprised on the state of the interior of the buildings. Repairs more than a good maintenance plan can cover. He also presented tabulated data from the community and educator surveys. Results indicate the importance on repair or replacing the middle school. Structure, electrical, fire suppression, site conditions, technology. How soon? Results said: Immediately or within 3 years. Comments included: water leaks, no barriers to stop a school shooter. Lack of electrical for technology. Feels the state of the facilities sets the stage for apathy in the student body. The buildings present well from the street. Many people have not been inside the buildings which would open their eyes.

Next Ben Rantilla of Hasenstab presented on the Building Life Cycle. All of our buildings and additions are in the final stage of the life cycle. Presented 4 possible building options: 1 new building, 2 new buildings, full renovation with additional classrooms for the middle school students. And selective renovation (pick and choose) with added classrooms for the middle school students.

A discussion followed and raised several questions including increased property taxes. There were questions on the JEDD. Finance was not the focus of this meeting but will be discussed at the next meeting. Another question was on the savings if the middle school is taken off line. C. Baldwin will bring that to the next meeting. The committee was given Post-it notes to write which option they preferred as a solution and place it next to one of the four options. FSM will tabulate the results and present them at the next meeting. Costs will be presented on each option along with required millage.

The next meeting is December 4, 2023. The goal of that meeting will be: Review renovation and new building options in more detail. Review budget options. Understand budget options in terms of real money.
